MainStream Global Solutions Wins CAAS IV \$4.5 Billion ID/IQ Subcontract

MainStream on Two of the 29 Winning Teams for the U.S. Materiel Command's CAAS IV Contract Vehicle

Bethesda, MD (February 10, 2012) — MainStream Global Solutions, LLC ("MainStream"), a leading veteranowned management consulting firm focused on increasing performance and sustaining gains for public and commercial sector organizations, is on two of the 29 prime-led teams that have been selected to supply a broad range of management and professional support services to the U.S. Air Force (USAF) Air Combat Command (ACC) under the Contracted Advisory and Assistance Services IV, also known as CAAS IV contract. MainStream is a team member on a small business team primed by Decypher-PSI (joint venture: Decypher Technologies LTD & Planned Systems International, Inc.) and a large business team primed by USfalcon, Inc.

Under the auspice of the USAF, CAAS IV is a five-year indefinite delivery, indefinite quantity (IDIQ) contract and has a contract ceiling of \$4.7 Billion and maximum task order value of \$50 Million. The contract award was awarded to 11 large companies, including USfalcon, Inc., and 18 small and mid-size companies, including Decypher-PSI.

The CAAS IV contract, managed by the ACC Acquisition Management and Integration Center, is a strategic initiative designed to support USAF mission objectives. This Advisory & Assistance (A&AS) award is to provide management and professional support services in order to support and improve policy development, management, administration, and the operation of systems. While the CAAS IV contract is specifically established within the Headquarters (HQ) ACC, this contract vehicle may be used by the HQ Air Force (HAF), Secretary of the Air Force (SAF) organizations, Air Force Office of Special Investigations (AFOSI), and the Office of Secretary of Defense (OSD) for its mission requirements throughout the Continental United States (CONUS) including Alaska and Hawaii, and outside CONUS (OCONUS).

"We are excited to expand our technical and business expertise throughout the U.S. Air Force," said John Maher, MainStream Vice President, Eastern Region Programs. "Our team has been preparing for this announcement and we are ready to support CAAS IV as a key member of the Decypher-PSI and USfalcon teams."
